Approval of Previous Meeting Minutes

 Ms. Brinson made a motion to approve minutes from May 22, 2024, meeting. Dr. Horne seconded the motion. All were in favor and the motion passed.

Financial Updates (Allie Pridgen, Director of Finance)

- Ms. Pridgen provided a summary of the FY25 Budget.
- Mr. Tatham made a motion to approve. Dr. Reed seconded the motion. All were in favor and the motion passed.

Public Health Updates (Mark J. Eanes, MD, MBA)

- South Health District held a Customer Service Training along with our Employee Appreciation Day on April 29.
- Dr. Eanes recognized Shannon Walker for being employed with the Department of Public Health for 20 years.
- Dr. Eanes informed the board of the Bird Flu outbreak that is affecting the poultry industry. It is known to be transmitted through dairy cattle only, however there are no signs in beef cattle.
- Legislative updates were discussed with Bill 293 being passed. AED, PREP for rape victims, DPH Clean-Up Bill. The telecommunications submitted by Public Health did not pass. This requires that all BOH meetings must be in person.
- Dr. Eanes presented a Memorandum of Understanding to our Board Chairman for his signature stating we would share staff from other counties if needed while someone was out and would get paid by county in which they are employed at.
- Pictures with QR codes have been placed in our lobby for patients to scan which will highlight success stories of local citizens.

Adolescent Health & Youth Development Updates (Percy Chastang, MPH)

- Mr. Chastang discussed what his program involves. He provides information on teen pregnancy, abstinence, HIV prevention and gives out personal hygiene products.
- Mr. Chastang informed the board of a Delta Program that is available at an alternative school.
- Mr. Chastang stated there is an expected grant for the Obesity and Diabetes Program.

Opioid Prevention Program Update (Ambreshia Allen)

- Ms. Allen is the Opioid Prevention specialist in our district. This program provides awareness and prevention around opioids and substance abuse.
- Ms. Allen provides training on overdoses and the use of Narcan.
- Ms. Allen provided the board with handouts with information on Brooks County.
- Mr. Maxwell stated there is funding in Brooks County for education and training in substance abuse.

Health Department Updates (Telia Alexander, RN)

- Ms. Alexander introduced Shanice King as the new lead administrator for Brooks County.
- Ms. Alexander provided updates on the CNM report.
- Ms. Alexander stated there has been an increase in child health forms and immunizations.
- Ms. Alexander stated there has been a decrease in Covid numbers.

Environmental Health Updates (Shannon Walker, MPH)

- Mr. Walker reviewed the Environmental Health activities report.
- Mr. Walker updated the State Body Art Rule to be approved. Dr. Reed made a motion to approve. Ms. Brinson seconded the motion. All were in favor and motioned passed.
