#### Call to Order

Dr. Fausett called the meeting to order at 12:05 PM.

#### Introductions

Dr. Fausett introduced Joy Folsom as a new member of the Cook County Board. Mrs. Folsom is the new interim superintendent of schools. Allie Pridgen introduced Budget Analyst Crumesha Johnson to the board members. Dr. Eanes introduced Karen Harrison as his new executive administrative assistant.

#### **Public Comments**

There were no public comments.

#### **Approval of Previous Minutes**

Mayor Buddy Duke made a motion to approve the minutes as written from the February 20, 2024, meeting. Col. (Ret) Ronald Mitchell seconded the motion. All were in favor and the motion passed.

#### **Business**

#### Financial Updates (Allie Pridgen)

- The Revenue and Expense Summary was reviewed for July 1, 2023, through March 31, 2024. The budget has been increased by \$47,908.00 since the last meeting to include prior fees that were collected. This came from intra agency funds transfer from Lowndes and for salary increases from program 750. Grant-In-Aid comes from the state, which is based on population and poverty index.
- Salaries and pharmaceuticals are the biggest increase in expenses for this quarter.
   The expense for repairs and maintenance is also reflected in this budget. Cook has 2 RN's, LPN, 2 Admin Staff and 1 Environmental that is paid out the Cook's budget. Part of County Nurse Managers salary is paid by the Family Planning Budget.
- The FY25 Budget 2025 was presented for approval by board. Terry McClain seconded the motion. All were in favor and the motion passed.

Public Health Updates (Mark J. Eanes, MD)

- Dr. Eanes updated the Board Members on some changes that are in the works to better serve in the health department. One example, there are several pictures around the health department that have QR codes that patients can scan. This will provide information on all services that are available in our health department and throughout the community. Dr. Eanes also informed the Board members that there have been cases of bird flu resurfacing. There has been one humanly documented case which caused conjunctivitis. It's mainly being transferred through dairy cattle.
- We have an updated memorandum of understanding that allows other nurses from our District to come into a health department to work when short staffed. It is required for the chairman of the board to sign. Now that the legislation has ended Dr. Eanes updated the Board on some of those changes that related to public health.
- There is a new DPH cleanup bill that states Public Health is no longer required to inspect jails or prisons.
- Any public or county places that have AED's are now required to have Narcan along with it
- Ken Lowery, District Epidemiologist, discussed with the board on opioids and opioid funding. There is a settlement of money in Georgia that will provide help to anyone that is in need. Mr. Lowery is looking for other funding sources as well from our county to help raise awareness and to provide training using Narcan. Our district is trying to work with Georgia Overdose Prevention Program to help put Narcan dispensing boxes around our county.

#### Nurse Manager Updates (Shelby Fulghum, RN)

Shelby Fulgham reviewed the number of clients seen during the last Quarter (January-March 2024). A total of 560 clients were served. We are seeing a steady increase in Pregnancy Case Management. This program is designed to help pregnant women get on Georgia Medicaid without going directly to DFACS. We have seen 151 clients that have come in for immunization during this quarter. These numbers should increase as the next school year approaches.

#### **Environmental Health Updates (Danielle Hurst)**

- Ms. Hurst reviewed Cooks environmental numbers from January 1, 2024– March 2024, which includes permitted facilities, food, and activities report.
- Cook County currently has about 80 facilities that are permitted. During this second quarter, Ms. Hurst has completed 66 food service inspections, and 7 hotel inspections.
   She has issued 25 septic permits, 23 well permits, collected 7 water samples, inspected 8 septic systems, and evaluated 3 existing septic systems.
- A list of restaurant scores for this time frame has been attached for the Board's review.
   Ms. Hurst offers staff training at no charge to help educate employees about safe food handling and maintaining the right food temperatures.
- Ms. Hurst has asked the board to vote on the body art rule adoption. This will allow the State to regulate the artist, however the county will permit the shop. Terry McClain

made a motion to approve the new body art adoption rule and Mayor Buddy Duke seconded the motion. All were in favor and the motion passed.

#### **Announcements**

Dr. Tom Fausett let the Board know that our next meeting will be held on August 20, 2024. Ms. Joy Folsom was officially sworn in today to be the newest member of Cook's Board. There were no other announcements.

#### Adjournment

There being no further business Dr. Fausett adjourned the meeting at 12:45 PM.
