Mr. Butler welcomed Karen Harrison as the new Executive Administrative Assistant for the South Health District

South Health District had an Employee Appreciation Day and Customer Service training on April 29, to help improve our customer service skills internally and externally.

Opioid Discussion – Kenneth Lowery, MPH (Epidemiologist)

Mr. Lowery discussed the Opioid Settlement Funding where the state of Georgia has been given \$363 million dollars which will be provided to each county within a twelve-year period, depending on the size and population of your county will determine what monies will be given. We are trying to expand programs specifically to hospitals for patients discharged with an

overdose to get resources to them informing of recovery places and Behavioral Health Services. Mr. Lowery stated that we can fulfill the needs of rural communities and provide to Police Officers, County Officers, Fire Departments, EMS, and any First Responders. The District Opioid Prevention Program will assist and provide training for members and staff.

Nurse Manager Updates (Mecca Lewis, RN, County Nurse Manager)

Ms. Lewis provided updated numbers of clients served with Tift County Health Department.

Environmental Health Updates (Jill Reade, MPH, Tift County EH Manager)

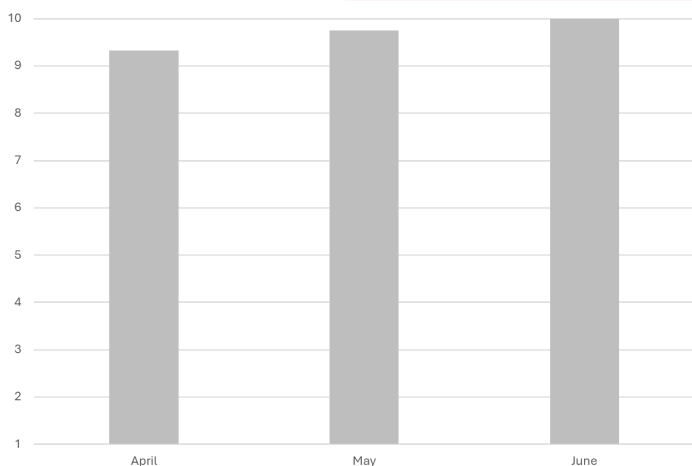

Diversified Enterprises Directors Report- July 2024

1) Reporting:

- a) The Monthly Financial report for June 2024 is not complete due to adjusting entries needing to be completed to accounts receivable for the end of the fiscal year.
- b) We are working on our annual CPA Audit to close out FY24.
- c) We are now at 100% occupancy for our group homes. We plan on licensing another 2-person group home in the new fiscal year.
- d) We continue to have issues with people we support losing their Medicaid eligibility without notice. We have resolved several of these cases, but new ones are happening every week.
- e) New Medicaid reimbursement rates were approved by DCH effective July 1. We are working on a budget revision that will include pay increases across the board to all DSPs to submit to the BOH for approval as soon as we receive the funding. We anticipate getting the back payment for what we have billed from July forward in the next couple of months.
- f) The Governor approved 4% pay increases to state employees effective July 1 with an additional \$1,000 bonus. We are awaiting the funding for the bonus in our FY25 State Contract before paying it out.
