Call to Order

Mayor Lumpkin called the meeting to order at 12:17 PM.

Introduction

Dr. Eanes introduced Brandon Ramella, District IT Director and Jessie Judkins, MS Early Intervention Coordinator with Babies Can't Wait.

Public Comments

No public comments.

Approval of Previous Minutes

Mr. Calhoun made a motion to approve May 29, 2024, minutes. The motion was seconded by Dr. Massey. All were in favor and the motion passed.

Business – Financial Updates: Allie Pridgen, Director of Finance (See Attachment)

- Ms. Pridgen reviewed the Revenue & Expense Summary for July 1, 2024 – September 30, 2024.

Public Health Updates: Mark Eanes, MD

- Dr. Eanes discussed the customer service surveys. As presented in the last meeting, there are customer service cards with a QR code that are given to each client to provide feedback on their experience in the clinic.
- Dr Eanes stated that during Hurricane Helene, Turner County was the only county within the district that wasn't affected by the storm. There was minimal power outage, and operations were back up and running as usual after the storm passed.

- Dr. Eanes informed the board that the legislative session is near and stated anyone that has concerns or suggestions for public health, please pass that along to your legislator.
- Dr. Eanes updated the board on the new building for the health department that had been previously discussed. There were some issues with the new building. The county has decided to keep the health department staff in their current building and make repairs or upgrades as needed.
- Mr. Calhoun asked for a priority list from the health department, so that the county will know what to focus on.

Babies Can't Wait Updates: Jessie Judkins, MS, Early Intervention Coordinator

Ms. Judkins presented in detail of the Babies Can't Wait program. The program provides services for babies, birth to 3 years of age with disabilities and delays.

Ms. Judkins stated her program is currently looking for providers for different types of services.

IT Updates: Brandon Ramella, MIS/IT Department Director

Mr. Ramella discussed in detail the role of the IT department for the district.

Mr. Ramella stated that the district is looking to move forward with Star Link satellite internet. He highlighted some instances that happened with other counties during Hurricane Helene. The IT department needs approval from the board to adjust the property and the building to install Star Link in Turner County Health Department.

Nurse Manager Updates: Mary Anne Sturdevan, RN

- Ms. Sturdevan presented the health department updates from July-September 2024.
- Ms. Sturdevan informed the board that flu vaccines are being given.
- Ms. Sturdevan discussed the lab drawing program.
- Ms. Sturdevan stated there is an increase in the number of patients needing lab services.
- Dr. Massey asked the lab's cost. Dr. Massey stated her concern about the cost being different between District 8-1 and a neighboring district.
- Dr. Eanes explained in detail the reason behind the costs.

Environmental Health Updates: Jill Reade, Environmental Health County Manager

- Ms. Reade updated the board on the Environmental Health Report.

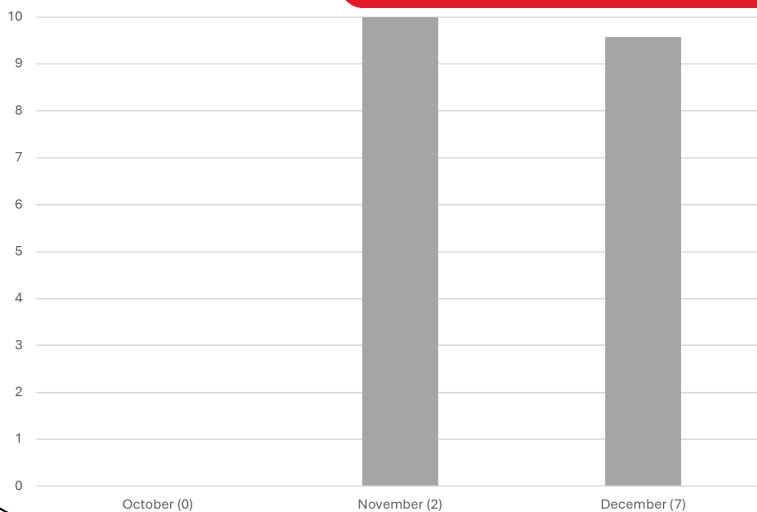
