#### **Call to Order**

Jimmy Parker, Vice Chairman, called the meeting to order at 12:40.

#### **Public Comments**

No public comments were made.

#### **Approval of Previous Minutes**

John Clayton made a motion to approve the minutes as presented from the August 12, 2024 meeting. Deree Nix seconded the motion. All were in favor and the motion passed.

#### **Business - Financial Updates (Allie Pridgen, Director of Finance)**

Mrs. Pridgen reviewed the Revenue and Expense Summary Report for the period July 1,2024 through September 30, 2024.

#### Public Health Updates - (Dr. Mark Eanes, MD, MBA, Medical Director)

- Dr. Eanes updated the board on Bird Flu and Mpox.
- Dr. Eanes stated that Mpox is declared a health emergency of international concern by the World Health Organization since the last meeting.
- Dr. Eanes stated that congenital syphilis has increased in Georgia.
- Dr. Eanes stated that all women who come into the health departments for pregnancy testing will also be tested for syphilis.
- Dr. Eanes updated the board on the THC cards.
- Dr. Eanes updated the board on the rules on Narcan in public buildings.
- Dr. Eanes stated that cities and counties in Georgia are receiving opioid funds from a 6year settlement.
- Dr. Eanes stated the South Health District can assist counties in using the funds for more education and opioid programs.

#### Babies Can't Wait / Early Intervention Program – (Jessie Judkins)

- Dr. Eanes introduced Jessie Judkins with South Health District's Babies Can't Wait / Early Intervention Program.
- Ms. Judkins explained to the board that the Babies Can't Wait Program provides early intervention for children from birth to three years old who have disabilities or delays in one or more areas of development.
- Ms. Judkins gave out packets of information on the services that are provided.

#### IT – Brandon Ramella - (MIS/IT Department Director)

- Dr. Eanes introduced Brandon Ramella, MIS/IT Department Director with South Health District.
- Mr. Ramella presented the board with information regarding Starlink Satellite.
- Mr. Ramella stated during Hurricane Helene the health department had power outages, and the loss of phone, and internet service
- Mr. Ramella stated by having Starlink, the clinic will be able to get notifications needed to preserve medications and vaccines.
- Mr. Ramella stated Starlink is our satellite internet solution that is being placed in all 10 counties in the district.
- Mr. Ramella stated the satellite receiver is installed outside near the employee entrance and does not require any local infrastructure.

#### Health Department Updates – (Dawn Bowen, RN, County Nurse Manager)

- Ms. Bowen reviewed the Berrien County Health Department updates for July 2024 -October 2024.
- Ms. Bowen stated that immunizations are one of the top services provided.

#### **Environmental Health Updates – (Lee Meeks, Environmental Health Specialist)**

- Mr. Meeks reviewed the Berrien County Environmental Health and Food Inspection update for the period July 2024- September 2024.
- Mr. Meeks stated Environmental Health prepared for Hurricane Helene by making sure all generators were serviced and operable in the anticipation of power outages.
- Dr. Eanes praised the Environmental Health team for coming together to make it possible for businesses to reopen once the power was restored.
- Dr. Eanes stated that there were 800 inspections and permits that were given after the hurricane.

There being no further business, a motion was made by Deree Nix to adjourn at 1:20 PM. The motion was seconded by John Clayton. All were in favor and the motion passed.


