• Ms. Pridgen reviewed the Revenue & Expense Summary for July 1, 2024 – December 31, 2024.

### Public Health Updates: Mark Eanes, MD

- Dr. Eanes welcomed Mr. Burgess to the board and being a newly elected County Commissioner.
- Dr. Eanes updated the board on the customer service surveys.
- Dr. Eanes noted that Turner County has great customer satisfaction.
- Dr Eanes updated the board on RSV, Flu, and Covid and states they have peaked at the same time and will become more seasonal.
- Dr. Eanes informed the board the state is reviewing the adult vaccines that are communicable and noncommunicable due to cost and utilization.
- Dr. Eanes stated Bird Flu remains a concern. There is no human-to-human transmission.

- Dr. Eanes stated congenital syphilis is still on the rise in Georgia.
- Dr. Eanes informed the board of a new law, the Drug Train Security Act.
- Dr. Eanes stated that all health departments will implement the use of scanners to track all medications.
- Dr. Eanes stated Public Health has a couple of bills going through the House. One is highlighting Women's Health. We offer a Perinatal Health program that provides healthcare for women in their homes.
- Dr. Eanes reminded the board that all BOH meetings must be held in person.
- Dr. Eanes addressed the Federal Funding Freeze.
- Dr. Eanes stated that DPH is on a travel ban due to President Trumps freeze.
- Dr. Eanes informed the board that GPHA is cancelled.
- Dr. Eanes updated the members on the move of the District Office.
- Dr. Eanes and Mr. Butler will be attending the county commissioner's meeting to present plans for a new health department and campus in Lowndes County.
- Mr. Burgess asked what programs could be cut, due to the freeze.
- Dr. Eanes replied, "Any of the programs". For instance, HIV clinic. It is federally funded through the Ryan White Foundation.
